Record of the minutes of a regular meeting of the City Council of the City of Minto, Walsh County, North Dakota, held on September 8, 2025, at 7:00 AM.

Mayor Larry Jamieson called the meeting to order, and the pledge was recited. Present were Councilmen Josh Miskavige, Lucas Kelley, John Narloch & Keith Shutt. Also, present was Peyton Cole, city attorney.

There were no additions to the agenda.

Mark Voeltz appeared before the Council to discuss the vacation of 5th Street between Wilson Avenue and Harvey Avenue. The Council informed Mr. Voeltz that if he follows the proper procedure for vacating a street, they will have no problem vacating that portion of 5th Street.

Ms. Cole had another update for the Council concerning Minto's municipal court. She has a contract started and the Council can approve it at the next meeting. Ms. Cole and Mayor Jamieson will need to attend a Walsh County Commission meeting to present the contract to Walsh County Commissioners.

The Council also agreed not to pay for an abstract to be drawn up for Lots 4 & 5 Block 5 of Stoltman's Addition. That will be the buyer's responsibility.

Minutes from the regular meeting held on August 11, 2025, were submitted for approval. A motion was made by Mr. Shutt to approve the minutes, seconded by Mr. Narloch, and carried.

Committee reports were given:

- Streets, Utilities & Lights
 - Mr. Shutt informed the Council that he had bladed 7th Street if the city still wanted to apply dust control to it. Mr. Paschke will contact Ice Dust Control. Mr. Shutt also suggested that either Brad Narloch or Trevor Slominski may allow the city to borrow a water truck to dampen the gravel to reactivate the dust control.
- Animal Warden
 - Mrs. Shutt requested that Ms. Cole send Todd Kidney a letter concerning the farm animals in the mobile home park. Mr. Shutt was informed that another trailer in the mobile home park will be demolished.
- Planning & Zoning
 - On a motion made by Mr. Shutt, seconded by Mr. Miskavige and carried, 1 building permit was approved:
 - o Patricia Grammer-new roof & decks
 - Mr. Kelley will speak to Angel Lopez concerning the shed he brought onto his property.
- Public Works Report
 - On a motion made by Mr. Shutt, seconded by Mr. Kelley and carried, the quote from Ironhide Equipment for a brush mower for \$8300.00 less a trade in value of \$4300.00 was approved.

Mrs. Shutt gave the Council an update on the concession stand at the park.
