

Unofficial & condensed minutes of a regular meeting of the City Council of the City of Minto, Walsh County, North Dakota, held on November 10, 2025, at 7:00 AM.

Mayor Jamieson called the meeting to order, and the pledge was recited. Present were Councilmen Miskavige, Narloch, Shutt & Kelley. Also present was Peyton Cole, city attorney.

There were no additions to the agenda.

Ms. Cole informed the Council that Walsh County is willing to take over our municipal court cases immediately.

The situation concerning the closure of the bridge over the Hariott Drain was discussed. Ms. Cole has been in contact with Jason Johnson, the Walsh County Highway Department Head, over the city's concerns about the closure and public safety.
