Unofficial and condensed record of the minutes of a regular meeting of the City Council of the City of Minto, Walsh County, North Dakota, held on May 14, 2018 at 7:00 PM at the Minto City Auditor's Office.

Mayor Larry Jamieson called the meeting to order. The Pledge was recited. Present were Councilmen John Narloch, Stanley Miller and Thomas Sitzer. Absent: Councilman Allen Gerszewski.

No open petitions from the public.

Minutes from the regular meeting held on April 9, 2018 were submitted for approval. M-Miller, S-Sitzer, carried. The minutes were approved.

Committee reports were given.

M-Miller, S-Narloch, carried. Signs admonishing motorists to watch for children will be ordered and placed on the West end of Harvey Avenue. Speed limit for the areas where the signs will be placed shall be 20 miles per hour and will be so stated on the signs.

M-Miller, S-Narloch, carried. Agreed to a raise of \$1.00 per hour for summer employee Chase Fenner. Seth Robison has been hired for summer help.

M-Miller, S-Narloch, carried. The following building permits were approved:

- Larry Frier shed, \$1,500. Contingent upon Mr.Frier ensuring that the building is constructed/placed at least six feet from the property line.
- Lori and Jim Federenko remodel bathroom and kitchen, \$20,000.
- Mark and Michele Spale driveway, \$2,000.
- Allen Robinson driveway, \$3,000.

Stacie Sevigny from Red River Regional Council attended the meeting to discuss the Housing Rehabilitation project. Eight applications have been received, with one being over the limit on income. M-Narloch, S-Gerszewski, motion carried. The deadline for people to complete an application has been extended to May 31. The three additional members of the Housing Committee appointed by Mayor Jamieson are Jane Misialek, Ryan Sobolik, and Carol Osowski. Councilman Narloch and Councilman Gerszewski had previously volunteered for the committee.

M-Miller, S-Narloch, carried. To send a letter to the Minto Fire Department and Fire Department Board requesting that the Council be informed prior to a controlled burn in the city limits.

M-Narloch, S-Sitzer, carried. Approved a gaming permit for the Park River Fire Department.

M-Miller, S-Narloch, carried. Approved the following Special Event permits:
